What Santa could receive in mileage allowance this year

If Santa were running his global gift delivery round under UK tax rules, his sleigh would sit neatly in the 'cars and vans' category for mileage claims. With an estimated 100,000,000 miles travelled in just one night, he would claim 45p per mile for the first 10,000 miles and 25p per mile after that.

That works out as £4,500 for the first 10,000 miles and £24,997,500 for the remaining miles covered. This gives a total potential mileage allowance of just over £25,000,000 for Christmas Eve alone. All of this would be fully deductible, helping Santa keep his festive finances in good order even with the reindeers doing the hard work.

Key dates & changes in 2026

31st January 2026

Deadline for submitting Self Assessment tax returns for the 2024/25 tax year and paying any tax owed to HMRC.

1st February 2026

Companies House are increasing their fees from 1st February 2026, including the Confirmation Statement filing fee from £34 to £50.
